

# Introduce Lime Scooters with Free Ride Credits



## Go Redmond and Lime Scooter Ride Credit Grant

Lime electric scooters have launched in Redmond as part of a one-year pilot program. These scooters will give Redmond travelers options as the average trip in Redmond is 2.2 miles, which is about a 15-minute scooter ride.

With this grant, Go Redmond will provide you with free ride codes for your employees or residents to use to try these scooters to get to lunch, meetings, and connect to transit. The app will charge \$1 to unlock and 25 cents per minute of your trip.

### Go Redmond will provide:

- Lime e-scooter ride codes.
- “How to” information and boiler plate communication pieces for scooter riders.

### You will provide:

- Communications to employees or residents about e-scooter safety, parking etiquette, and the free ride codes.
- Space for a 1 hour event, hosted by Lime, to teach people about scooters
- Evaluation of your Scooter Ride Credit program to Go Redmond.

### About the Grant & Lime Scooters:

Lime will host a tabling event at your site to talk to employees and residents about using the electric scooters and can provide helmets to attendees of the event. You will just need to coordinate a date and provide some space for the event (lobby area, parking lot, etc). We also ask that you make one or two helmets (provided by the grant) available to residents and employees to use.

We will then provide you with ride codes or credits that can be distributed to your employees/residents. For employees or residents to use the scooters, simply download the Lime app, unlock the scooter by scanning the QR code located on the handlebars. The app will charge \$1 to unlock and 25 cents per minute of your trip when the free ride codes are not in use.

- Educational materials about scooters & sample communication pieces to promote scooters

#### Employer Will Provide:

- Communications to employees or residents about Scooter safety and parking etiquette.
- Space for a 1 hour event, hosted by Lime, to teach people about scooters
- Evaluation of the event to Go Redmond (number of participants, overall success, etc.)

### II. Indemnity:

Each Party shall protect, defend, indemnify and save harmless the other Parties, their elected officials, officers, employees, and agents, from any and all costs, claims, judgments, and/or awards of damages, arising out of or in any way resulting from each Party's own negligent acts or omissions in performing work under this Agreement. Each Party agrees that it is fully responsible for the acts and omissions of its own subcontractors, and their employees and agents, acting within the scope of their employment as such, as it is for the acts and omissions of its own employees and agents. Each Party agrees that its obligations under this provision extend to any claim, demand, and/or cause of action brought by or on behalf of any of its employees or agents. The foregoing indemnity is specifically and expressly intended to constitute a waiver of each Party's immunity under Washington's Industrial Insurance Act, RCW Title 51, as respects the other Parties only, and only to the extent necessary to provide the indemnified Parties with a full and complete indemnity of claims made by the indemnitor's employees. The Parties acknowledge that these provisions were specifically negotiated and agreed upon by them.
